RULES

ELIGIBILITY

The regatta is open to boats of the Flying Scot whose skipper is a member of Flying Scot Sailing Association.

ENTRY and FEES

REGISTRATION:

Eligible boats may enter by registering on-line via the Corinthian Sailing Club's website (http://www.cscsailing.org/2007_FS_districts_reg_form.html) or completing the attached form and sending it, together with the required fee, to Flying Scot Fleet 23, c/o Renee Comen, 3509 Leighton Ridge Drive, Plano, TX 75025. Registration must be received May 13, 2007. Registration received after this date will be subject to a \$15.00 late fee.

Windward/Leeward, Gold Cup, Olympic

SCORING

The Low Point System of Appendix A will apply.

One race constitutes a regatta.

RADIO COMMUNICATION

A boat shall neither make radio transmissions while racing nor receive radio communications not available to all boats. This restriction also applies to mobile telephones.

PRIZES

Prizes will be given as follows: First through Fifth Place
